## Working temperature

Recommended working temperature: 325 to 375°F.

It is not recommended to go beyond the running temperature range. Bond quality and processing can be affected by application temperature.

Due to the variety of substrates available, adhesion of materials can be very different. Therefore pre-tests should be carried out. See also "General Instructions for the Application of Hotmelts". Material is applied hot. Appropriate clothing and eye protection should be used. Adequate ventilation is recommended when using this product. Refer to Safety Data Sheet.

## Storage

Rotate stock using oldest material first. Do not mix with other adhesives. When stored in a dry and cool place in the original unopened containers, shelf life is as follows.
