Recommended working temperature: 250 to 300 °F

The recommended application temperature is  $275^{\circ}F$ , however the specific application requirements may require customization.

It is not recommended to go beyond the running temperature range.

Bond quality and processing can be affected by application temperature.

#### Handling Information

Due to the variety of substrates available, adhesion of materials can be very different. Therefore pre-tests should be carried out. Material is applied hot. Appropriate clothing and eye protection should be used. Adequate ventilation is recommended when using this product. Refer to Safety Data Sheet.

#### STORAGE

Rotate stock using oldest material first. Do not mix with other adhesives. When stored in a dry and cool place in the original unopened containers shelf life is as follows.
